Thank you for your email of 23 October highlighting the comments provided by your constituent, Mr John Sayce of Wheelrights, Swansea Bay's Cycling campaign, in response to the recent consultation on the National Transport Delivery Plan (NTDP).

Your constituent raises a number of important issues and I would like to thank him for taking the time to consider and respond to the consultation. My officials have confirmed that his response was received on 10 October and will be carefully considered alongside all other responses in developing the final version of the document.

The NTDP is the document which states how we will deliver the priorities and objectives laid out in the Wales Transport Strategy. This plan shows how we will better integrate journeys across different modes of transport, provide better more reliable and attractive public transport services, make tickets less complicated, and ensure people feel safe whilst travelling.

Our priorities for this five year delivery plan are:

- to bring services to people in order to reduce the need for people to use their cars on a daily basis. This will involve planning ahead for better physical and digital connectivity, more accessible services, more home and remote working and more active travel.
- to allow people and goods to move easily from door to door by accessible, sustainable and efficient transport services and infrastructure. We will do this by investing in low carbon, accessible, efficient and sustainable services and infrastructure that enable more people to walk, cycle and use public transport, and low emissions vehicles.
- to encourage a shift to sustainable transport and to make using public and active travel the easy thing to do.
